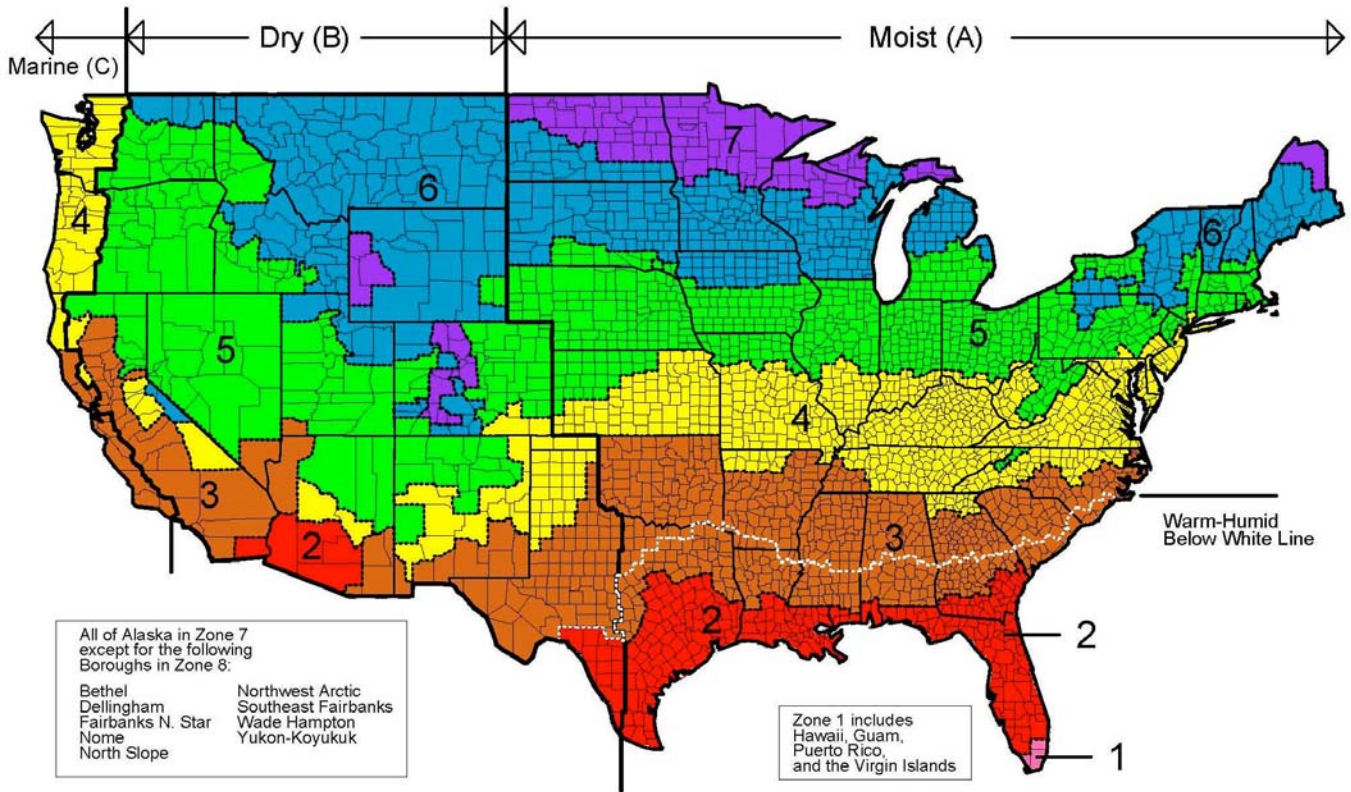

- 4) The presence or absence of dividers, screens, exterior or interior shading devices, shading from foliage, buildings or homes, etc. or shading from overhangs does not affect the qualification status.
